FY 2009 TDCJ Substance Abuse Felony Punishment Facility Offender Characteristics

The following data highlights general characteristics of offenders in Substance Abuse Felony Punishment Facilities (SAFPFs) as of 8/31/2009, those admitted to SAFPFS during fiscal year 2009, and those released from SAFPFS during fiscal year 2009. The data do not include characteristics of prison offenders, state jail offenders, or offenders in Intermediate Sanction Facilities (ISFs). The data were extracted from individual-level records submitted to the LBB by TDCJ-Executive Services and may differ from the TDCJ Statistical Report due to methodological differences.

SAFPFs provide an intensive six-month chemical dependency treatment in a secure setting to offenders with a substance abuse problem. Offenders can be placed in the program as an initial condition of community supervision or as a modification of parole/community supervision.
