## SELECT DATA FOR FISCAL YEAR 2012 ADMISSIONS

#### **OBJECTIVE**

The Texas Department of Criminal Justice's (TDCJ) statutory mission is to provide public safety, promote positive change in offender behavior, reintegrate offenders into society, and assist victims of crime. TDCI is organized into multiple divisions and organizational units. Five of the agency's divisions carry out its major responsibilities regarding offenders: the Community Justice Assistance Division. the Correctional Institutions Division. Rehabilitation Programs Division, the Reentry and Integration Division, and the Parole Division.

#### **KEY FACTS**

- ♦ 81.1 percent of state jail offenders were sentenced to incarceration for one year or less.
- ◆ 36.9 percent of state jail offenders were admitted for a drug or alcohol related offense.

#### **STATUTORY REFERENCES**

Texas Government Code, Chapter 491

The data highlight offense and sentence characteristics of offenders admitted to state jail facilities during fiscal year 2012. State jails house offenders convicted of state jail felonies. The punishment range for these offenders can range from 180 days to two years. The data do not include characteristics of prison offenders, Substance Abuse Felony Punishment participants, or parole violators in Intermediate Sanction facilities. The data were extracted from individual-level records submitted by Texas Department of Criminal Justice (TDCJ) Executive Services and may differ from the TDCJ Statistical Report due to methodological differences.
